OF

This Deed of Trust Executed on this 26th day of October one thousand nine hundred and ninety four by Shaukat Ali S/o Late Dost Mohammad aged about 65 years, residing at Karja Post Semariawa Bazar, Distt. Basti hereinafter called the "AUTHOR OF THE TRUST".

WHEREAS the Author is desirous of constituting a Public Charitable Trust for the welfare of Muslim in particular and other weaker classes and minorities in India and abroad as hereinafter mentioned:

WHEREAS with the said purpose, the Author has set apart a sum of Rs.10,001/- (Rupees Ten Thousand One Only) which he has handed over to the Trustees hereinafter mentioned to hold the same upon trust together with all the income arising therefrom and all the accumulations and accretions thereto for the intent and purposes and objects herein contained:

AND WHEREAS the Author desires to reduce to writing the terms of the Trust.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:-

1. The Author has this day transferred and given upto the Trustees a sum of Rs. 10,001/- (Rupees Ten Thousand One Only) to be held upon trust together with all the income arising therefrom and all the accumulations and accretion thereto for the intent and purposes and objects herein contained.

2. The name of the Trust shall be "AWADH PUBLIC CHARITABLE TURST".  
Village P.O. Semeryawan
3. The office of the Trust shall be at "Karja, Basti U.P."
4. The Trust shall be for the welfare of the Muslims particular and other weaker sections and minorities in India and abroad.

5. AIMS & OBJECTS:

The aims and objects of the Trust shall be:

- a) To establish, maintain, run, develop, improve, extend, grant, donate for and aid in the establishment, maintenance, improvement and extension of teaching Medical Colleges, Para medical Colleges, Nursing Colleges, Pharmacy Colleges so that such institutions could also serve the purpose of providing the requisite clinical training necessary for the prosecution of medical studies and act as necessary adjuncts to medical education.
- b) To establish, maintain, run, develop, improve, extend, grant, donate for and to aid in the establishment, maintenance, improvement and extension of teaching Engineering Electrical, Electronics, Computer, Architecture, Space Engineering and all other allied services and Engineering Colleges, Polytechnical Colleges, Technical & Vocational Colleges, Training Centers etc.
- c) To establish, maintain, run, develop, improve, extend, grant, donate for and to aid in the establishment, maintenance, improvement and extension of teaching Primary schools, Residential schools, High School, Arts & Science Colleges etc. to impart knowledge in Primary education, in Arts & Science, Legal, Accountant, and religious subjects;

- d) To establish, maintain, run, develop, improve, extend, grant, donate and to aid in the establishment, maintenance improvement and extension of medical and pharmaceutical laboratories and technicians training programmes;
- e) To set up hospitals/nursing homes and assist hospitals in setting up various facilities such as Blood Banks, Eyes, Bank, Burn Centres, etc. for the poor patients;
- f) To institute studentship, scholarships, stipends, medals, prizes etc. to help and encourage deserving students and to provide monetary aid to students, scholars and Teachers for pursuing their educational activities;
- g) To organise, conduct and assist in the organising and conducting of lectures, seminars and symposia on subjects of relevance and interest to the students in the institutions referred herein;
- h) Grant of endowments at Universities, Research institutions and other Educational and Scientific institutions whether now existing or hereinafter established for spread of education and knowledge in all fields or any branches of knowledge;
- i) To provide food, clothing and or shelter Medical aid to the poor people and destitutes and the aged;
- j) To establish, maintain and/or grant aid to homes, orphanages, or other establishments and institutions for relief of and to give help to the poor and destitute people, orphans and widows;
- k) To donate sums of money or to perform marriages of men and women who are poor and deserving or to present articles and materials of use to married persons on occasions of their marriages, who are poor and deserving;
- l) To organise, run and assist in the organising and running of free medical camps and also to run mobile medical services.



- m) To assist and provide for construction of community halls, rest houses, etc.
- n) To provide drinking water facilities, wells, pumps and other means to provide the supply of water needed for the community;
- o) To lay and improve roads, maintain them and generally to provide easy accessibility for men and animals and to create public shelter on such means of accessibility;
- p) To provide sewerage facilities, latrines, bathing places, etc. with a view to improve conditions of sanitation and to promote hygienic living;
- q) To make donations to other public charitable Trusts/ Institutions recognised under Section 80-C of the Income Tax Act, 1961;
- r) To spread, literacy, temperance, social harmony and general awareness among the people so as to make them better and more useful citizens;
- s) To help and assist deserving social organisations and other such trusts who are engaged in public welfare;
- t) To do all that is necessary and incidental for the purpose of achieving the objects mentioned above;
6. In pursuance of the above object the trust say:
- a) Acquire by purchase, lease, mortgage, will, gift, grant, legacy, bequest, exchange, right privilege or otherwise from any person, company, society, Government, Institution, Organisation or privilege or otherwise from any person, company, society, Government, Institution, Organisation or anybody whatsoever, movable or immovable properties of all description deemed necessary or useful for any purpose of the Trust.
- b) Erect Buildings or structures, whatsoever to further any purpose or purposes of the Trust and to maintain, develop, improve, alter, repair, demolish or reconstruct the same or any portion thereof.

- c) Take or receive any gifts, whether money or property, movable immovable, donations in the form of debentures, stocks, shares or securities in any Company or Society whether incorporated or not or whether by gift by a person living or by legacy bequests, will or foundation and whether subject to any special trust or for works connected therewith and to take steps for the securing of such contributions for funds as from time to time be deemed expedient.
- d) Alienate by way of sale, mortgage, lease, release, loan, charge, hypothecate, pledge exchange hiring out, gift of properties or funds of the Trust or any portion or portions thereof including the making or giving or subscriptions, contributions, assistance pecuniary or otherwise to such institution, bodies or persons as from time to time deemed necessary or expedient.
- e) Lend money free of interest, invest, lay aside, deposit in Bank or otherwise deal with moneys of funds of the Trust not immediately required for the objects of the Trust and to subscribe or purchase, acquire hold, sell, endorse and negotiate in debentures, stocks, shares and securities of every description in the money market, in conformity with the provisions contained in Section-20 of the Indian Trust Act, 1882.
- f) Borrow or raise funds with or without security in any manner the trust may think fit and repay the same.
- g) Negotiate with and enter into arrangements, with any Government, Authority, Corporation, Board University or other Public Bodies as may seem conducive to the promotion or accomplishment thereof & to obtain, collect, receive such grants, loans, allowances, rights, concessions and privileges as may seem to comply with the objects and utilise the same.
- h) In general to do or cause to be done apart from all the acts stated above, all such other acts or things as shall be conducive to the interests of the Trust provided such things or acts be not contrary to nor inconsistent with the spirit and principles of law under which the trust has been established.

## 7. DURATION OF TRUST:

The trust hereby created shall be irrevocable and its duration perpetual and permanent, subject to other residuary clauses of this Deed.

## 8. TRUST PROPERTY:

The term "TRUST PROPERTY" shall mean and include the said sum of Rs. 10,001/- (Rupees Ten Thousand One only) set apart by the Author and further grants, donations, contributions of money and/or property movable or immovable that may be made by the founder or by others from time to time.

## 9. TRUST PROPERTY TO VEST WITH:


The Trust property shall vest in the Board of Trustees comprising of Permanent and Ordinary Trustees who shall hold, manage and administer the trust in accordance with the terms and conditions hereof.

## 10.A. PERMANENT TRUSTEES:


a) The following shall be the Permanent Trustees of the Trust:

- i) Shaukat Ali S/o Late Dost Mohammad, aged 65 years, Resident of Karja, P.O. Semariawan Bazar, Distt. Basti.
- ii) Akbar Hussain S/o Late Haji Anjad Ali, aged about 64 years, R/O Village & P.O. Hatwa Bazar, Distt. Basti.
- iii) Abdul Hakeem S/o Late Dost Mohammad, aged 40 years, R/O Karja, P.O. Semariawan Bazar, Distt. Basti.
- iv) Abid Ali Khan S/o Late Naitullah, aged 66 years, R/O Village- Karja, Distt. Basti.
- v) Abdul Rashid aged about 68 years, R/O Village- Dariabad, Dist. Basti.
- vi) Baqar Hussain S/o Liaqat Hussain, aged about 59 years, R/O Vill. & Post Hatwa Bazar, Distt. Basti.
- vii) Atiqur Rahman S/o Mohammad Sami, aged about 52 years, R/O Vill. & Post Karahi, Distt. Basti.

- b) The permanent Trustees shall hold office during their life time unless they resign.
- c) SHRI SHAUKAT ALI shall be the CHAIRMAN OF THE TRUST FOR LIFE. The lifetime Chairman shall nominate the future Chairman of the Trust during his lifetime and thereafter the Permanent Trustees shall elect the Chairman among themselves and the Office of such elected Chairman (other than the life time Chairman) shall be for a period of THREE YEARS.
- d) The Chairman of the Trust shall nominate the Managing Trustee/Joint Managing Trustee/Secretary/Treasurer among the Permanent Trustees.
- e) The permanent Trustees in future shall be inducted, appointed by the majority of the Permanent Trustees. The composition of such Permanent Trustees shall consist of the members from the family of Late Shri Dost Mohammad.
- f) The minimum number of Permanent Trustees shall be 6 (six) and the maximum shall be 18 (Eighteen).

B. ORDINARY TRUSTEES:

a) The following shall be the FIRST ORDINARY TRUSTEES;

i) Prof. A.M. Khusro of Delhi  
S.A.

ii) Maulana Hashmi of Delhi

iii) Maulana Sadiq (write complete Name)

iv) Mr. Maqbool Ahmad, Retd. Principal of Basti.

b) The Ordinary Trustees in future shall be nominated/ appointed by the Chairman of the Trust from time to time.

c) The Ordinary Trustees shall retire by rotation in every 3 (Three) years and are eligible for reappointment.

d) The minimum number of ordinary Trustees shall be THREE.

C. Notwithstanding what has been stated in these clauses, any of the trustees may retire after giving a calendar month's notice in writing of his/her intention to do so to each of the other trustees for the time being and upon expiry of the notice period, the trustee giving such notice shall ipsofacto cease to be the trustee of the Trust.

11. BOARD OF TRUSTEES:


The permanent Trustees and Ordinary Trustees shall constitute the Board of Trustees.



- a) To employ clerks and other employees, agents, bankers, lawyers, accountants and others on such remuneration as they may think fit;
- b) To withdraw any power or revoke any appointment of any employee or person;
- c) To let any portion of any immovable property forming part of the Trust fund, at such rent and for such period and on such terms and conditions as they may think fit and accept surrender of any lease;
- d) To convert, call in, sell or otherwise dispose of any of the investments comprised in the Trustee property and reinvest or change the nature of any other investment contained therein;
- e) To invest trust moneys in Fixed Deposits with nationalised banks, government securities and or any other investments subject to the provisions of clause 21 of this deed;
- f) To sell any immovable property belonging to the trust;
- g) To raise loans on mortgage of the trust properties either movable or immovable and to execute necessary papers, documents in that behalf;
- h) To borrow funds with or without security of the property and for this purpose to mortgage, charge and encumber any assets of the trust either movable or immovable.
- i) To appoint proxy or proxies for voting any meeting of creditors, contributors, contributories, shareholders or otherwise;
- j) To establish and/or run trusts and other institutions having objects of similar nature that of this trust;
- k) To delegate any powers as they can lawfully delegate to any other person and to execute such power as they may think fit for the purpose;

13. The Trustees shall open a bank account in the name of the Trust, therein deposit all moneys payable to and receivable by them by virtue of these presents and shall keep and maintain or shall cause to be kept and maintained proper books of accounts subject to audit by a Chartered Accountant.
14. The Bank Account in the name of the trust will be operated under the directions of the Board of Trustees.
15. The office of the Trustees shall be honorary but they are entitled to draw such allowances as are prescribed by the Board for carrying out their duties.
16. a.) Any Trustee who becomes a bankrupt, lunatic, convicted of criminal offense, involving moral turpitude, or neglects to take interest continuously for a period more than six months or is physically incapacitated shall cease to be the Trustee of the Trust.  
b) Any Trustees may retire on giving notice of one Calendar month in writing of his/her intention to do so.
17. a) The Trustees may reimburse themselves or pay and discharge out of the said Trust properties all expenses incurred in or for the execution of the objects of the Trust and exercise of the powers vested in them.  
b) The Trustees are fully indemnified against expenses and losses incurred or suffered or any payments made by them in the administration of the Trust. Such expenses, losses and payments shall be borne by the Trust and none of the Trustees shall in any manner be personally liable or responsible for the same.
18. All deeds and other documents to be executed by or on behalf of the Trust shall be done by the Managing Trustee of the trust and the trust may sue or be sued in the name of the Managing Trustee of the Trust.

19. MINUTE BOOK:

Minute book shall be maintained at the office by the Board of Trustees. Minutes of all meetings, appointments and entry into the office of every new trustee and all other proceedings of the Board of Trustees shall be signed by the Chairman of the meeting either at the conclusion of the meeting or at the subsequent meeting when they are duly confirmed.

20. MAJORITY DECISION;

Any decision taken by majority of the Permanent Trustees including the Chairman at any trust meeting, shall be valid and binding on all the Trustees. In arriving at a majority decision in such board meetings, in the event of tie, the Chairman shall have a casting vote and decide the matter, provided however, in the matter of alteration of any of the clauses of this Trust Deed, the same shall be valid only when not less than three fourth of the Permanent Trustees shall decide so.

21. INCOME TAX EXEMPTION:

All these powers of the Trustees prescribed herein of the trust Deed, shall be exercised as to ensure that the income of the trust would be exempt under Section 10(22), 10 (22A) and/or 11 of the Income Tax Act, 1961 as amended from time to time. It is clarified that the power of investment of the trust funds including those mentioned in clauses above shall be exercised in such a manner so as to ensure exemption of the Income of the Trust under the relevant provisions of the said Act.

22. ALTERATION OF RULES OF TRUST:

The Permanent Trustees, by a majority, are empowered to alter the rules governing the administration of the trust in manner not inconsistent with the objects of the trust, provided that such amended rules are in no way repugnant to the provisions of clause 21 of this Deed.

23. PROVISION OF DETERMINATION OF THE TRUST:

In the event of the determination of the Trust or if this Trust should fall in any reason the Trustees shall make over or transfer the funds and properties of this Trust to any other Trust or Institution having objects generally similar to those of this Trust and to which are exempt under Section 80-G of the Income Tax Act, 1961, if the resolution to that effect is passed by the Trustees unaniously or by not less than three fourth majority provided that under no circumstances, the properties or assets of the trust at any time be distributed among the Author or the Trustees.


