NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:-



4. The Trust shall be for the welfare of the Muslims this particular and other weaker sections and minorities in India and abroad.

5. AIMS & OBJECTS:

- To provide drinking water facilities, wells, pumps and other means to provide the supply of water needed for the community;
- To lay and inprove roads, maintain them and generally to provide easy accessibility for ten and animals and to create public shelter on such means of accestibility;
- p) To provide sewerage facilities, latrines, bathing places, etc. with a view to improve conditions of sanitation and to promote hygienic living;
- q) To make donations to other public charitable Trusts/ institutions recognised under Section 80-C of the Income Tax Act, 1961;
- To spread, literacy temprance, co unal harmony and general awareness among the people so as to make them better and more useful citizens;
- To help and assist deserving social organisations and other such trusts who are engaged in public welfare;
- t) To do all that is necessary and incidental for the purpose of achieving the objects mentioned above;
- In pursuance of the above object the trust may:
- Acquire by purchase, lease, nortgage, vill, gift, grant, legacy, bequest, exchange, right privilege or otherwise from any person, company, society, Covernment, Institution, Organisation or privilege or otherwise from any person, company society, Government, Institution, Organisation or anybody whatsoever, movable or immovable properties of all description dremed necessary or useful for any purpose of the Trust.
- b) Errect Buildings or structures, whatsoever to further any purpose or purposes of the Trust and to maintain, develop improve, alter, repair, demolish or reconstruct the same or any portion thereof.

- Take or receive any gifts, whether money or property, movable immovable, donations in the form of debentures, stocks, shares or securities in any Compan, or Society whether incorporated or not or whether by gift by a person living in by legacy bequests, will or foundation and whether subject to any special trust or for works connected there with and to take steps for the securing of such contributions for funds as from time to time be deesed expedient.
- Alienate by way of sale, mortgage, lease, release, loan, charge, hypothecate, pledge exchange hiring out, gift of properties or funds of the Trust or any portion or portions ther of including the making or giving or subscriptions, contributions, assistance 'pecuniary or otherwise to such institution, bodies or persons as from time to time deemed necessary or expedient.
- e) Lend money free of interest, invest, lay aside, deposit in Bank or otherwise deal with moneys of funds of the Trust not immediately required for the objects of the Trust and to subscribe or purchase, acquire hold, sell, endorse and negotiate in debentures, stocks, shares and securities of every description in the money market, in conformity with be provisions contained in Section-20 of the Indian Trust Act, 1882.
- f) Borrow or raise funds with or without security in any manner the trust may think fit and repay the same.
- Negotiate with and enter into arrangements, with any Covernment, Authority, Corporation, Board University or other Public Bodies as say seen conductive to the promotion or accomplishment thereof & to obtain, collect, receive such grants, loans, allowances, rights, concessions and privileges as may seem to comply with the objects and utilise the same.
- h) In general to do or cause to be done apart from all the acts stated above, all such other acts or things as shall be conducive to the interests of the Trust provided such things or acts be not contrary to nor inconsistent with the spirit and principles of law under which the trust has been established.

- d) To convert, call in, sell or otherwise dispose of any of the investments comprised in the Trustee property and reinvest or change the nature of any other investment contained therein;
- e) To invest trust moneys in Filed Deposits with nationalised banks, government securities and or any other investments subject to the provisions of clause 21 of this deed;
- f) To sell any immovable property belonging to the trust;
- E) To raise loans on mortgage of the trust poperties either movable or immovable and to execute necessary papers, documents in that behalf;
- h) To borrow funds with or without security of the property and for this purpose to mortgage, charge and encumber any assets of the trust either movable or immovable.
- To appoint proxy or proxies for voting any meeting of creditors, contributors, contributors, shareholders or otherwise;
- j) To establish and/or run trusts and other institutions having objects of similar nature that of this trust;
- k) To delegate any powers as they can lawfully delegate to any other person and to execute such power as they may think fit for the purpose;

- 15. The office of the Trustees shall be honorary but they are entitled to draw such allowances as are prescribed by the Board for carrying out their duties.
- 16.3.) Any Trustee who becomes a bankrupt, lunatic, convicted or criminal offense, involving moral turpitude, or neglects to take interest continuously for a period more than six months or is physically incapacitated shall cease to be the Trustee of the Trust.
- b) Any Trustees may retire on giving notice of one Calendar month in writing of his/her intention to do so.
- 17.a) The Trustees may reimburse themselves or pay and discharge out of the said Trust properties all expenses incurred in or for the execution of the objects of the Trust and exercise of the powers vested in them.
- The Trustees are fully indemnified against expenses and losses incurred or suffered or any payments made by them in the administration of the Trust. Such expenses, losses and payments shall be borne by the Trust and none of the Trustees shall in any manner be personally liable or responsible for the same.
- All deeds and other documents to be executed by or on behalf of the Trust all be done by the Managing Trustee of the trust and the trust may sue or be sued in the rome of the Managing Trustee of the Trust.

20. MAJORITY DECISION:

Any decision taken by majority of the Permanent Trustees including the Chairman at any trust meeting, shall be valid and binding on all the Trustees. In arriving at a majority decision in such board meetings, in the event of tie, the Chairman shall have a casting vote and decide the matter, provided however, in the matter of alteration of any of the clauses of this Trust Deed, the same shall be valid only when not less than three fourth of the Permanent Trustees shall decide so.

21. INCOME TAX EXEMPTION:

All these powers of the Trustees prescribed herein of the trust Deed, shall be exercised as to ensure that the income of the trust would be exempt under Section 10(22), 10 (22A) and/or 11 of the Income Tax Act, 1961 as amended from time to time. It is clarified that the power of investment of the trust funds including those sentioned in clauses above funds including those sentioned in clauses above shall be exercised in such a manner so as to ensure exemption of the Income of the "rust under the relevant provisions of the said Act.

22. ALTERATION OF RULES OF TRUST:

The Persanent Trustees, by a majority, are empowered to alter the rules governing the administration of the trust in manner not inconsistent with the objects of the trust, repugnant to the provisions of clause 21 of this bead.
